Bidders shall present its confirmation receipt to the BAC Secretariat in person, by facsimile, or through electronic means, which shall be used as proof of payment for the bidding documents fee.

Bids must be submitted in sealed envelopes with the title of the procurement project name, name of Bidder, address of the Bidder, and contact details of the Bidder, duly received by the BAC Secretariat through manual submission at the office address indicated below on or before May 5, 2025 at 9:45 in the morning. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on May 5, 2025 at 10:00 in the morning at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
