



**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AS A RESULT OF POST- QUALIFICATION AND RECOMMENDING AWARD FOR THE SUPPLY AND DELIVERY OF VARIOUS BARGO MERCHANDISE – RE-BIDDING**

**RESOLUTION NO. 15, S. 2025**

**WHEREAS**, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing the contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

**WHEREAS**, in accordance with pertinent provisions of RA 9184, the BAC published on 03 April 2025 in the PhilGEPS, SLSU website and BAC Bulletin board the Invitation to Bid (IB) for the **Supply and Delivery of Various BARGO Merchandise – Re-Bidding** under Project No. **PB 2025-G&S-05** with a total Approved Budget for the Contract (ABC) amounting to **One Million Four Hundred Three Thousand Three Hundred and Twenty-One Pesos only (₱1,403,321.00)**;

**WHEREAS**, in furtherance with the provisions of the Revised RA 9184, representatives from the Commission on Audit (COA) as well as observers from private sector and non-government organization, were invited to observe and witness the conduct of the Pre – Bid Conference, Submission and Opening of Bids, Evaluation of Bids, and Post-Qualification as scheduled;

**WHEREAS**, on 23 April 2025, BAC passed Resolution No. 14, s. 2025 declaring the Lhorlie Tailoring as the Lowest Calculated Bid (LCB).

**WHEREAS**, on 24 April 2025 to 19 May 2025, upon careful examination, validation and verification of all technical and financial proposals submitted by the Lhorlie Tailoring, BAC found their bid offers to be compliant with all the legal, technical and financial requirements, and declared as the Lowest Calculated and Responsive Bid (LCRB) with a total contract amount of **One Million Two Hundred Ninety-Three Thousand and Nine Hundred Pesos only (₱1,293,900.00)**

**NOW, THEREFORE**, with the foregoing premises considered, the undersigned members of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED**:

1. To declare the Lhorlie Tailoring with the Lowest Calculated and Responsive Bid;



2. To recommend to the SLSU Board of Regents as the University 's Head of Procuring Entity (HoPE) to award the contract to the abovementioned supplier.
